She often employs the human body to tell a story and convey specific emotions. Every detail adds to the drama of the overall painting. Born in Rivne Ukraine, Alla received her BFA from Memphis College of Art and her MFA from Laguna College of Art and Design. She teaches at Miracosta College.

ENTRY FEES

PRESENTATION OF ART

All two-dimensional media accepted. Each entry must be no larger than 30 inches on any side, including frame and must weigh no more than 25 pounds. Wire hangers only with ends wrapped for safety. (No sawtooth hangers). Each piece should be identified on the back with the artist name, title of piece, and price;

SALES

Brandon Gallery will retain 30% of sales. All work must remain through the close of show.

DELIVERY FOR JUDGING

Art must be delivered to Brandon Gallery on Friday April 20 or Saturday April 21 between 11 and 3.

By submitting entry the artist agrees to release any and all Brandon Gallery members and show juror from financial responsibility for his or her work in the event of theft, fire, breakage or other damage while on the premises. Brandon has the right to use images for promotional purposes.
